



## ACRYLIC SPAS Limited Warranty

### Cabinet: 5 years parts & labor

Myhottub.com warrants the original retail purchaser the integrity of the spa's cabinet structure will not rot, crack, or peel as a result of defects in material or workmanship for 5 years. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

### Acrylic Spa Shell: 5 years parts & labor

Myhottub.com warrants the original retail purchaser the integrity of the spa's shell against water loss through the spa shell as a result of defects in material or workmanship for 5 years. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

### Plumbing & Equipment: 2 years parts & 2 years labor

Myhottub.com warrants the original retail purchaser the integrity of the spa's plumbing against leaks as a result of defects in material or workmanship for a period of 2 years on parts and 2 years on labor. Myhottub.com warrants the original retail purchaser the integrity of the spa's Equipment Pack (pumps, heater, control system) to be free from defects in material and workmanship for a period of 2 years on parts and 2 years on labor from the date of the original retail purchase. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

### Replacement Only: 1 year

Myhottub.com warrants the original retail purchaser the integrity of the spa's accessories (where applicable): Including jet inserts, pillows, and standard spa cover for one year. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

### Warranty Specifics

- **Ozonators:** Myhottub.com warrants the original retail purchaser that the factory installed ozonators will not malfunction due to defects in workmanship for a period of 1 year from the date of the original retail purchase.
- **LED Lighting:** Myhottub.com warrants the original retail purchaser that the factory installed LED Lighting System will have a 1 year warranty to be free from defects in workmanship and materials from the date of the original retail purchase.
- **Sound System:** Myhottub.com warrants the original retail purchaser that the factory installed Sound System will have a 90 day warranty to be free from defects in workmanship and materials from the date of the original retail purchase.

**Please Note: Electrical Connections must be made by a qualified, licensed residential electrician. Improper installations present hazards which can result in personal injury or property damage and void the warranty on the spa. Please see the Pre-delivery Guide and/or Owners Manual for additional information.**

### Exclusions

This limited warranty is enforceable only by the original retail purchaser. Fuses, covers, light bulbs, light lenses, seals on pump and motor, and any dealer installed accessories are specifically excluded from this limited warranty.

All warranties are null and void if any of the following occur:

- the spa has been subject to alteration, neglect, misuse or abuse.
- any damages caused by failure to install, maintain, and operate the spa in accordance with the recommendations contained in Myhottub.com Owner's Manual.
- Any and all costs of spa's removal and replacement including but not limited to removal and transportation, damages to landscaping, house structures.
- The spa has been used in a non-residential application or an application in which it was not designed.
- Spa shell damage caused by excessive heat build-up due to failure to cover the spa while empty of water and/or exposure to direct sunlight.
- Any damages caused by improper maintenance of spa water chemistry or by any undissolved spa chemicals which may cause bleaching of the spa shell and erosion or discoloration of stainless jets.
- Any repairs that are done by any one other than authorized Myhottub.com agent, or anyone without expressed written permission by Myhottub.com warranty department.
- Any and all costs associated with obtaining warranty service. Myhottub.com is not responsible for any form of Trip Charge requested by a service provider.
- Do not use third-party salt-based systems in your spa! Damage caused by salt-based systems that have not been factory installed will not be covered under your warranty.

**IMPORTANT:** Myhottub.com Warranty is void if the spa is moved to any location that is not the original 'Ship To' address.
